Here are the latest prepared statements of the accounts for the Enford Community fund and a list of donations made from the fund, up until the last award that was made whilst I was still secretary/treasurer. You will see that for these years, with no fete occurring (2019 due to lack of people willing to help in running the event and in 2020 due to COVID) and attendance at the fireworks affected by poor weather, the fund suffered considerable losses in both these years, thus affecting the available funds for causes within the parish.

I am immensely proud of the team and its achievement of raising and awarding over £20,000 in funds benefiting causes within our own community. I stepped down at the end of 2019 but obtained information from Gareth and Richard to complete the 2020 year end as very little happened during lockdown.
